

# Health and Safety Resource List: Health and Safety Program Practice for Providers

## Introductions

The Child Care and Development Fund (CCDF) final rule outlines regulations for implementing the Child Care and Development Block Grant (CCDBG) Act of 2014 and administering the CCDF program, including provisions to protect the health and safety of children in care. The final rule strengthens health and safety requirements for programs receiving CCDF funds. All American Indian and Alaska Native (AI/AN) CCDF grantees, regardless of allocation size, are required to meet the health and safety requirements in the final rule.

This resource list provides information for child care providers on health and safety program practice in AI/AN CCDF child care programs.

## Provider Resources

AI/AN CCDF grantees are required to establish health and safety standards for providers regarding 11 required health and safety topics. The resources below can assist providers with meeting standards and implementing best practices to protect the health and safety of children in care.

### Topic 1: Prevention and Control of Infectious Diseases (including immunizations)

This topic includes processes for preventing and responding to health and medical issues and addresses proper hygiene and sanitation. Proper hygiene and routine cleaning, sanitizing, and disinfecting can prevent infection and illness. This topic also covers requirements related to immunization of children and staff in early care and education settings.

Training can help early childhood staff prevent, identify, and report shaken baby syndrome and child abuse and neglect. This section also outlines activities that should be avoided because they are harmful to children's health, safety, and well-being, such as suspension, expulsion, abuse, maltreatment, and excessive punishment.
